# **New Features**

This release of the Fastmarkets Dashboard includes new functionality and features including:

• New - NYMEX NY Harbor ULSD (Heating Oil) futures – first 12 future contracts added

# NYMEX NY Harbor ULSD (Heating Oil) futures

This release will add the first 12 future contracts for Nymex NY Harbor ULSD futures to the Dashboard. Though the full forward curve trades out to the next 12 calendar years, this will be the first implementation of this data set. These futures were known as Heating Oil but transitioned to ULSD (Ultra Low Sulphur Diesel) in 2013.

These new futures are available in the Historic Price Table, Price Chart and Single Price tile providing an end of day Settlement price. The Multi Price Table displays the Bid, Ask, Last, Close, Settlement and Volume.

These futures are available only as rolling contracts showing the latest continuous month eg. front month, second month.
